Flood	Yes	No cover for flood for the first 48 hours after the start of this policy except in certain situations.
Storm	Yes	No cover for storm for the first 48 hours after the start of this policy except in certain situations.
Accidental breakage	No	Accidental glass breakage is included.
Earthquake	Yes	No cover caused by high tide, tidal wave, tsunami or other actions of the sea.
Lightning	Yes	We do not cover loss or damage if there is no evidence of damage.
Theft and Burglary	Yes	We cover theft or attempted theft but not if caused by you, your family or a tenant.
Actions of the sea	No	No cover for loss or damage caused by high tide, tidal wave, tsunami or other actions of the sea.
Malicious damage	Yes	We do not cover malicious damage caused by you, your family or a tenant.
Impacts	Yes	No cover to commercial aerials, antennas and masts.
Escape of liquid	Yes	No cover to associated repairs to the apparatus, tanks or pipes.
Removal of debris	Yes	This benefit is in addition to your building sum insured. Limited to 10% of your building sum insured.
Alternative accommodation	Yes	We will pay the reasonable cost of comparable accommodation for you and commercial accommodation for your pets that live with you, for a period of up to 12 months while your building is being repaired or rebuilt.

STEP 3 Other things to consider

Limits

A number of different excesses may apply in respect to this policy, for example a basic excess or an imposed excess. You may be able to increase these excesses to lower your premium. - you set the maximum level of cover and the insurer may provide you with some agreed extra cover above that amount (*Sum insured plus safety net*).
- the insurer will cover all the reasonable costs to rebuild your home (Total replacement).

You can choose either Unspecified Personal Valuables cover or Specified Personal Valuables cover. In some instances limits will apply, items need to be described and valuations or receipts provided.
