

## RAC Insurance "Kid Tales 2021" Competition TERMS AND CONDITIONS

- 1. The promoter of the "Kid Tales 2021" competition is RAC Insurance Pty Limited ABN 59 094 685 882 (the Promoter).
- 2. This document and the instructions on how to enter the "Kid Tales 2021 Competition" form part of these Terms and Conditions.
- 3. Participation in the Competition constitutes the entrant's unconditional agreement to and acceptance of the Terms and Conditions.
- The RAC Insurance Kid Tales 2021 Competition (the Competition) begins on 18/10/21 at 8:00am (Australian Western Standard Time) and ends on 22/11/21 at 4:00 pm (Australian Western Standard Time) (Competition Period).
- 5. The Competition is open to WA residents who have children and they themselves are aged 18 years or over at the start of the Competition Period.
- 6. Entry to the Competition is not open to employees of the RAC Group of Companies.
- 7. To create an eligible entry to this Competition, during the Competition Period a person must be eligible to enter the competition and:
- a child must draw themselves on an adventure from their weekend or holidays. This could be any activity within the home, on a road trip or at any destination in WA;
- b. a parent or guardian must upload the child's drawing to their Instagram or Facebook feeds;
- c. their Instagram or Facebook account must be publicly accessible;
- d. accompany the post with the hashtag #racwakidtales.

(Eligible Entry).

8. During the Competition Period, there will be a total of five competitions, with one Minor Competition winner selected each as follows:

## **Minor Competitions**

- announced on RAC WA Instagram account by 2/11/216:00 pm;
- Second winner: Competition open from 12:00 am 25/10/21 to 11.59pm 1/11/21, one winner selected by the Promoter at 9am 2/11/21 and announced on RAC WA Instagram account by 9/11/21 6:00pm;
- Third winner: Competition open from 12:00 am 2/11/21 to 11.59pm 8/11/21, one winner selected by the Promoter at 9am 9/11/21 and announced on RAC WA Instagram account by 16/11/21 6:00pm;
- Fourth winner: Competition open from 12:00 am 9/11/21 to 8:00am 15/11/21, one winner selected by the Promoter at 9am 16/11/21 and announced on RAC WA Instagram account by 23/11/216:00pm.

## **Major Competition**

The Major Competition winner will be selected as follows:

- Fifth winner: Competition open from 8:00 am 18/10/21 to 11.59pm 21/11/21, one winner selected by the Promoter at 9am 22/11/21 and announced on RAC WA Instagram account by 29/11/216:00pm
  - 9. Entries must be received through Facebook and Instagram channels utilising the hashtag mechanic during the Competition Period. Only one unique image entry may be received per eligible entrant (identified by unique image), although an entrant can submit multiple entries. Any duplicate entries will not be considered for any prize.
  - Each Eligible Entry must be unique and may only be considered for one Minor Competition prize or the Major Competition prize.
  - 11. The Promoter reserves the right to not approve or to exclude any entrant for any reason it sees fit in its absolute discretion.
  - 12. Prizes will be emailed to winners where possible. The Minor Competition prizes and the Major Competition prize will be processed as an email to the winner's nominated email address only after:
- a. the winner has been contacted by RAC via social media and accepted the Prize within the time specified in these Terms and Conditions; and
- b. the winner has provided RAC with email address details and identification when accepting the Prize and had their identity verified by RAC.



- 13. Minor Competition winners will be contacted via their social media accounts (Facebook or Instagram) to confirm they accept their prize.
- 14. Each Minor Competition winner will receive one of the following prizes:
- a. Day Pass to Adventure World for 5 (2 adults+ 3 children / 1 adult + 4 children) valued at \$246
- b. Perth Zoo close encounter experience for 4 (2 adults + 2 children, any child below 4 can accompany for free) valued at \$150
- c. Flying Trapeze Workshop (2 hours) for 4 (any 4 people) valued at \$292
- d. IFly Kickstart flight for 4 (any person aged 3+) valued at \$320

(Minor Competition Prize)

- 15. On 22/11/21, one Eligible Entry (excluding Minor Competition winners) will be selected as the Major Competition prize winner. The Major Competition prize will be won by one winner with an Eligible Entry.
- 16. The Major Competition winner will receive a single prize consisting of:
- a. Travel package consisting of a \$2,000 RAC Esperance Holiday Park accommodation voucher and \$7,000 RAC Travel voucher (to cover flights, hire car and scenic tours) valued at \$10,000 and valid from 29/11/2021 until 29/11/2023.
- 17. The Promoter shall in its sole and absolute discretion choose:
  - a. a winner of each Minor Competition Prize; and
  - b. a winner of the Major Competition Prize, by selecting an Eligible Entry that it deems suited to the photo entry guidelines. This is not a competition of chance.
- 18. The Minor Competition Prize winners will be chosen by RAC Insurance as per the judging criteria. Each Minor Competition Prize winner will be notified by social media message on Facebook or Instagram within 24 hours of selection as the Minor Competition Prize winner. All Minor Competition Prize Winners will be listed on the RAC's competition page in the conclusion of the Competition.

- 19. The Major Prize Competition winner will be selected by a panel of RAC members selected by the Promoter as per the judging criteria. The Major Prize Competition winners will be notified by social media message on Facebook or Instagram within 24 hours of selecting the entry. The Major Competition winner and each Minor Competition winner will be announced on the RAC WA Instagram account within 7 days of selection. The Major Competition Prize Winners will be listed on the RAC's competition page in the conclusion of the Competition.
- 20. By accepting the relevant prize, the Major Competition winner and each Minor Competition winner each confirm that RAC WA can share their name and entry and on the RAC Instagram and Facebook accounts.
- 21. If the Major Competition winner or any Minor Competition winner does not accept their prize within 24 hours of that winner being notified, then that winner will be revoked, and a new winner will be selected in their place.
- 22. All prizes offered under this Competition are not transferable, exchangeable or redeemable for cash. If the specified prize becomes unavailable for any reason, the Promoter may substitute a prize of like or equal value.
- 23. The Promoter reserves the right not to select winners of all or any prizes in its absolute discretion.
- 24. The Major Prize RAC Esperance Holiday Park voucher (The Holiday Park Voucher) is valid for 2 adults and 2 children (under 12). This prize is redeemable during all seasons. Valid at RAC Esperance Holiday Park in specified accommodation type only – Two Bedroom Bay Villa, for 5 nights stay. The Holiday Park Voucher Cannot be used in conjunction with any other offer, discount or sale rate. The Holiday Park Voucher can be used in conjunction with the RAC member rate. The Holiday Park Voucher can only be redeemed at the specified park/s until 29/11/2024 and is subject to availability. The recipients stay must take place before this date. Redeemable on accommodation only, excludes food & beverage, activities and tours. The Holiday Park Voucher is not transferable, or redeemable for cash.

The Major Prize RAC Travel voucher (RAC Travel Voucher) is valid for credit to spend with RAC Travel, and this prize includes return flights to Esperance, 5 days car hire and scenic tours (flight or cruise) for a family of four. Cannot be used in conjunction with any other offer, discount or sale rate. The RAC Travel Voucher can only be redeemed at the specified RAC Travel suppliers until 29/11/2024 and is subject to availability. The recipient's bookings must take place before this date. Redeemable on flights, car hire and tours only, excludes food & beverages and activities from non-preferred suppliers. The prize is not transferable, or redeemable for cash.
- 26. By entering, all entrants authorise the Promoter, RAC Insurance Pty Limited to use the entry content for marketing, advertising and other business purposes without requiring any additional consent from the entrant and without compensating the entrant.
- 27. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
- 28. The Promoter reserves the right to disqualify an entry if the entrant has breached any of the Terms and Conditions or their entry is misleading.
- 29. The Promoter reserves the right to:
- a. declare as void any entries or claims for prizes resulting from any printing, production or distribution errors or where there has been error in any aspect of the preparation for or conduct of the Competition materially affecting the result of the

- competition or the number of Winners or the value of claims for prizes;
- add to or to waive any of the Terms and Conditions;
   and
- c. cancel the Competition or any part of it at any stage.
- 30. This Competition is subject to the Promoter's Privacy Policy available at <a href="rac.com.au/about-rac/site-info/privacy">rac/site-info/privacy</a>. Entrants must notify the Promoter if they would like to amend their personal information or if they have any queries as to how their personal information will be used.
- 31. If the Competition is conducted on, or utilising, social media including, without limitation Facebook, Instagram and Twitter, the Competition shall be subject to the terms of use governing the applicable social media platform. In the event of an inconsistency between these Terms and Conditions, and the terms of use of the applicable social media tool, the terms of the applicable social media tool shall prevail.
- 32. Without prejudice to clause 31 above, if the Competition is conducted on Facebook and/or Instagram, entrants:
  - a. fully release Facebook and/or Instagram (as applicable) from all liability arising out of the Competition;
  - b. acknowledge that the Competition is in no way sponsored, endorsed or administered by, or associated with, Facebook and/orInstagram; and
  - c. understand and accept that information disclosed in connection with the Competition is disclosed to the Promoter and not Facebook and/or Instagram (as applicable).
